THE RULES – TERMS OF PARTICIPATION:

1. The film length/duration excludes beginning & end credits. Credits overlapping the film shall be included in the length of the film.
2. The films to be shot in any format including Handycam, PD 170, DV, miniDV etc..
3. The films shall be submitted on a DVD. The DVDs are to be sent to:
www.1takemedia.com FILM COMPETITION, **1664, Dadabhai Niwas, Ground Floor, Building No. 42, D N Nagar, Andheri (W), Mumbai 400053**. The DVDs may either be delivered in person or sent by courier / mail, alternatively the films could be uploaded directly on www.1takemedia.buzz18.com
4. All DVDs shall be labeled with the Title, Director's Name and Format of the film. A synopsis of the film and biography of the director shall also be submitted along with the entry.
5. The last date for submitting the film shall be 31ST March 2009 (received by www.1takemedia.com).
6. Films can be in English, Hindi or any other language, however, **all films will have to be sub-titled in English.**
7. The film maker shall continue to hold the IPR for the film(s) submitted, however, all rights including but not limited pertaining to distribution, exhibition, alteration, modification, screening, etc., of the films submitted shall rest with www.1takemedia.com hereinafter referred to as the "Organiser" in perpetuity. By submitting the film for the competition the film makers, producer, etc. do hereby transfer all the rights as mentioned hereinabove to the Organiser and give up any claims, compensations, rights, etc on the said film. Normally, the Organiser shall not have any objection for screening of the submitted films at festivals or for non-commercial display, however, the film makers are required to take prior written permission from the Organiser.
8. The Organiser offers to pay a royalty to the film maker @ 50% of the "Net Receipts" received by them for their film submitted. "Net Receipts" shall mean the final amount actually received by the Organiser reduced by the amount of expenses incurred by the Organiser for generating the revenue. In the event the film is sold as a part of a package / lot then the "Net Receipts" shall mean the amount after deducting the expenses as mentioned hereinabove from the total receipt and the share proportionate to the weightage the particular film has in the package / lot. The weightage of each film in the package / lot shall be decided by the organiser, which shall be final and binding.
9. The decision of the jury/Organiser in all matters shall be final, and binding on all participants.
10. Once submitted the films cannot be withdrawn for any reason whatsoever.
11. No materials, documents, etc. submitted for participation shall be returned under any circumstances and shall become the property of the Organisers.
12. The scheduling, timetable and screening of the winners' films shall be at the discretion of the Organisers.
13. The filmmakers, producers, etc. hereby indemnify and keep indemnified the Organisers against any loss, cost, or expense (including attorneys' fees), due to any claim by themselves and/or any other parties relating to the said film or its rights.
14. Entry and participation of films implies unconditional acceptance of the regulations.
